# **About the Host University**

### **Courses and professors**

I decided to take strictly finance related courses as NYU is a top 3 finance program in the world. I was truly blown away by the quality of professors, material and educational experience. Some of the courses that I took were:

<u>Valuation</u> – I absolutely loved this course. It was taught by professor Sagram who is Domodoron's right hand guy. This course was intensive but practical and was easily one of the best courses I have ever taken.

<u>Bankruptcy & Restructuring</u> – This course was a half course but was unforgettable. It is taught by Dr. Altman who is world renowned in distressed markets. The final project is analyzing a bankruptcy and making recommendations.

Mergers & Acquisitions – Taught by an Israeli professor – it is challenging but well worth it. It gives you a deep dive on how M&A works and is very useful if you want to go into consulting or investment banking.

<u>Private Banking</u> – Cool course taught by three different lecturers. This course was the easiest by far and was the coolest. Had many speakers come in and was the most industry-related course.

<u>Corporate Finance</u> – Good course, provided fundamental lessons about finance that helped understand more complex courses.

Out of these, I would highly recommend Valuation and Bankruptcy as they provide foundational finance knowledge and skills that allows you to really understand day-to-day finance related news.

### **Accommodation**

Finding accommodation was a bit difficult and I recommend starting a couple months in advance.
