

2022-2023 FACTSHEET INCOMING EXCHANGE PROGRAM

International Programs Office (IPO)

Nomination

Students from partner schools must apply for the Fuqua exchange program with the coordinator at their home school and are exclusively nominated by their home institutions. Nominations must be sent directly by the primary exchange contact to annie.floyd@duke.edu.

The nomination deadlines are the same for students attending for one semester (12 weeks) or one session (6 weeks). The timing of nominations directly impacts the visa application process for each student.

Nomination deadlines are as follows:

- Fall exchange deadline is the 30th of April each year
- Spring exchange deadline is the 31st of August each year

Admission

Once the IPO has received the official nomination, Annie Floyd will contact the students to initiate their admission into the program. Students will be asked to submit an online form with information required for their matriculation at Duke. It is imperative that students comply with the deadline for submitting this information as all subsequent steps rely on the matriculation process, including the visa application. Failure to do so will jeopardize the student's opportunity to study at Fuqua.

The matriculation process can take up to five weeks before visa applications can even begin. Please coordinate with the IPO if there is be a delay in submitting the information. Failure to submit the matriculation information by the deadline may result in termination of the exchange.

Once the student has been matriculated, he or she will receive an email with information on how to log into their Duke account. This will give them access to email, registration, and student health, as well as other services.

The Duke University Visa Services Office does require proof of English proficiency for the exchange program. Students may provide scores from a recognized English test or a letter from their current school confirming both English proficiency for the Fuqua MBA program and functioning on a day-to-day basis.

Immunizations

US immunization requirements are regulate for all individuals attending the school; these requirements are decided by individual states. Duke University's immunization requirements are set by the State of North Carolina. These requirements may be different from your school or country of origin.

In order to attend Duke University, you must comply with North Carolina immunization requirements. Failure to complete this requirement may result in sanctions on student accounts, including but not limited to withholding transcripts. More information will be provided by the IPO and Student Health prior to your arrival at Duke.

Arrival and Housing

Both Fall and Spring exchange students are expected to arrive in time to attend the **Mandatory Exchange Student Orientation** at the beginning of each term. Attendance is required to register your visa. It is strongly recommended that students arrive in time to get acclimated before their semester/term begins, therefore the orientation sessions are scheduled several days before the start of classes.

The J-1 visa status in which exchange students are permitted to enter the country will allow a 30-day grace period before the beginning of the exchange program (orientation date) and an additional 30-day grace period after the end of their exchange program (last day of exams).

Should there be delays or difficulties with the visa application, the IPO advises students to NOT purchase airline tickets until the visa application process is completed.

Fuqua does not provide housing for students; however the IPO will provide exchange students with housing information. Additionally, the <u>Duke International House</u> can provide a wealth of information on <u>local housing</u>. Most exchange students prefer to share accommodations with other exchange students as a way to minimize costs. Students arrange housing on their own and can find wonderful resources online, such as:

Student Services

Orientation: There is a specific, mandatory exchange student orientation in each term of each semester for exchange students.

International House: Duke's International House offers a wide variety of programming and resources for all international students and their spouses.

Mentor System: Exchange students will be connected with second year students who will introduce them to classmates and Team Fuqua.

Advising: The Program Manager of the International Programs Office will act as the exchange students' advisor. The main point of contact for incoming exchange students is the Program Manager, Annie Floyd.

Computer Services: Exchange students have full access to the state-of-the-art Fuqua Computer Mediated Learning Environment, which includes email, full internet access, on-line multi-level bulletin boards, and file transfer protocols.

<u>Library</u>: The Ford Library at Fuqua has excellent library facilities with many on-line databases for extensive academic and career research. Exchange students are also free to use Duke University's extensive library system.

Social Activities: Exchange students are invited to participate in a wide range of student and school social activities, including clubs, "Fuqua Friday," social events, intramural sports, community lunches, outings, etc.

Dining: Food service is available at the Fox Student Center.

Transportation & Parking: If you are planning on purchasing a car, exchange students may purchase a parking permit for their car from the Duke Parking Office. Alternative transportation, campus & city bus passes will also be available to students.

<u>DukeCard</u>: Each exchange student will have access to a mobile ID card from the DukeCard Office. The DukeCard is used to open building doors, access parking lots, and buy goods and services at Duke using a Flexible Spending Account (FLEX).

Visa Information

ALL Exchange students come to Duke University on a J-1 nondegree student visa. The J-1 visa is considered to be the most appropriate visa status for exchange students as it is specifically designed for educational exchange.

Instructions will be emailed to all students to begin their J-1 visa application. After the online webform is completed by the student, and supporting documentation is received by the IPO, the Duke Visa Services Office will process the visa application and send the DS-2019 directly to each student. This process takes approximately 2 weeks from the time the IPO receives the student's completed application. Students must take the DS-2019 to the nearest US Embassy or Consulate to apply for the visa.

All visa deadlines that are communicated to the students regarding the visa application are strictly enforced. Failure to submit the online webform AND supporting documents by the requested deadline WILL result in cancellation of the exchange. This deadline is generally six weeks prior to orientation.

It is extremely important that students follow ALL instructions on the online visa application forms and send all the necessary documents to the IPO staff in a timely manner to prevent delay. Immigration regulations and possible background checks can delay the process, so please take the necessary steps as soon as possible. Please keep in mind that there may be considerable delays at US Embassies and Consulates abroad.

Learning Environment and Courses

The Fuqua School of Business maintains excellent facilities for graduate business education. The academic year at Fuqua is divided into two 12-week semesters that each made up of two 6-week terms. The Fall semester is comprised of Fall 1 & Fall 2 and the Spring semester of Spring 1 & Spring 2. Exchange students participate in the regular second-year MBA curriculum and are only allowed to enroll in elective courses.

Courses meet twice a week for 2 hours, 15 minutes each (Monday/ Thursday or Tuesday/Friday). There are no classes on Wednesdays. A broad range of elective courses may be taken, such as: Accounting, Decision Sciences, Economics, Finance, Health Sector Management, Management, Marketing, Operations Management, Strategy and Sustainability. Class size is approximately 35-70 students per class. All courses are taught in English. Due to the high level of classroom participation, group work, and interaction among students and faculty, exchange students must be proficient in written and spoken English.

Classroom attendance and participation are mandatory. According to Fuqua policy, students are <u>not</u> allowed to arrive after the start of classes. The final course grade may be based on case analyses, class participation, team projects, oral and written presentations, midterms and final papers or examinations. The format varies from course to course, but class participation is often a significant portion of the final grade. The exam period is during the last three days of each term. Registration and Course Requirements

Fuqua's semester is broken down into two, six week sessions. Each semester is comprised of Fall 1 and Fall 2 or Spring 1 and Spring 2. There is a short break from classes between sessions.

Exchange students studying at Fuqua for an entire semester (two, six week sessions) must enroll in a minimum of 4 courses. If an exchange student wishes to enroll in more than 4 courses, this is allowed with special permission from the Registrar.

For students studying at Fuqua for one session (6 weeks) they are expected to enroll in a minimum of 2 courses and a maximum of 3 courses without Registrar's permission. Students that wish to enroll in more than 3 courses may do so with Registrar's permission.

Most Fugua courses are 3 credits, but some courses are 2 credits.

A 3 credit Fuqua class accrues 27 contact hours, or in-class time.

Course information and course registration instructions is released by the Fuqua Registrar's office prior to the start of each semester. Course listings and descriptions are available on the Fuqua website. Fall course schedules will be available by the beginning of July. Spring course schedules will be available by the beginning of November. Exchange students will register for classes via their DukeHub account.

Career Management Center

While the primary objectives of the Exchange Program is academic and cultural and not professional, Fuqua and the Career Management Center (CMC) also provide a number of career resources for our visiting exchange students. These services include:

- GTS Document Library CMC's career resource website which contains a variety of documents, online tools, and workshop recordings.
- Access to Fuqua and Duke LinkedIn Groups and the Fuqua Alumni Directory
- Ford Library Career Resources
- Career coaching via CMC walk-up hours

A complete description of these resources will be provided upon arrival. Internships, following the exchange, on a J-1 visa may be possible through Academic Training. Historically, students have only been successful with this option in rare instances.

Important Notes on the Exchange

- The maximum duration of exchange per student is two terms. No exceptions will be made to this rule.
- US citizens and dual citizens who hold a US passport may only be nominated for exchange at Fuqua if they have a significant amount of educational and work experience outside of the US. Prior to nominating a student, the primary exchange contact at the home school should email the student's resume or CV to Annie Floyd for consideration.
