Modules

Exchange students should select from the list of **MBA elective modules** offered. Exchange students who wish to select **core modules** must obtain approval from home university. This is also subjected to approval from professors and vacancy in class at NUS Business School.

MBA exchange students at NUS are required to complete a minimum of two MBA modules. Students who wish to take cross-faculty modules (including Real Estate and Health Care Management modules) will be considered by the module host department on a case-by-case basis, depending on availability and vacancies of these modules. Note that NUS offers cross-faculty modules every semester but often with very limited vacancies for MBA exchange students.

Real Estate Modules
