# **OVERVIEW**

The Sauder School of Business is pleased to welcome exchange students to join our Master of Business Administration program for **Fall 2021\***. We are a popular destination for MBA exchange students from schools throughout the world for our strong teaching and research reputation, international diversity and our spectacular natural setting.

The University of British Columbia (UBC), established in 1908, is one of Canada's leading research universities and is consistently ranked among the top 40 in the world. The university attracts 61,113 students from across Canada and 140 countries around the world to two major campuses.







#### **Vancouver Campus**

The largest campus is 30 minutes from the heart of downtown Vancouver, a spectacular location that is a 'must-see' for any visitor to the city — where snow-capped mountains meet ocean and breathtaking vistas greet you around every corner. # MBA EXCHANGE ACADEMIC OVERVIEW

Term Dates: The Exchange Term covers two periods within the Fall 2021\*

Period 4: **September 7 – October 16, 2021\*\*** 

Exam week: October 12 – 16, 2021

Break (no scheduled classes): October 18 – 31, 2021

Period 5: **November 1 – December 11, 2021\*\*** 

Exam week: December 6 – 11, 2021

\*For Fall 2021, we do not yet know whether our MBA classes will return to in-person instruction. In the even that in-person instruction is not yet possible, we anticipate classes to be fully on-line with some in-person program experiences throughout the term.

#### Students take four courses per each Period.

Note: Professional Development seminars are held throughout the term. Exchange students may request to participate along with the Full-Time MBA class.

**Structure and Delivery of Classes:** Lectures, seminars, case studies, project works, group work, presentations and field trips.

Language of Instruction: English

**Teaching Hours:** 1 Course = 1.5 credits or 20 credit hours (note: Exchange students take 8 courses over two periods from September to beginning of December)

Class Size: 50 students max in class; average 26 students in a class.

**Course Load:** 4 courses per period (8 courses over duration of Exchange term)

**Grading:** Percentage system used; 60% = Minimum Pass

**Examinations**: Final Evaluations are held during the last week of class (during week 6 of each of Period 4 and Period 5). Final evaluations may involve a written examination and/or oral presentation, written paper, or assignment.

## COURSES: SELECTION & REGISTRATION

Course listing for Periods 4 and 5 will be made available to incoming Exchange Students in June 2021.

Exchange Student Application: April 23, 2021

Mandatory Orientation: September 2 and 3, 2021\* (see note above)

**Housing:** On-Campus, single-student housing (**not guaranteed**); housing applications are received by **May 1**<sup>st</sup>, **2021**.

Students looking to secure off-campus accommodation should expect to spend \$800 - \$1,200 CAN per month for a 1 bedroom accommodation.

**Visa Details:** A Study Permit is only required of international students who plan to study and live in Canada for <u>more than six months</u>. Given exchange duration is under 6-months, non-Canadian students are not required to obtain a Study Permit. **Medical Insurance:** Exchange students at UBC are required to obtain the IMED: Health Insurance for New International Students. There is a charge of \$252 CAD\* for this insurance which will provide basic medical coverage during the exchange term.

**Orientation & Tour of Vancouver** (if possible): To assist students in assimilating to life at the Sauder School of Business, the University of British Columbia and Vancouver, a one-day mandatory Exchange Student Orientation is held on **Sept. 2**<sup>nd</sup> and the Tour of Vancouver on **Sept. 3**<sup>rd</sup>.

## ESTIMATED EXCHANGE EXPENSES

Exchange students are exempted from paying UBC MBA tuition since tuition is paid to the home institution. The following fees and expenses are only ESTIMATES for a single student and are subject to change without notice. Expenses are in Canadian dollars and may vary depending on the student's own personal spending habits.
